ART LOAN CARE AND HANDLING GUIDELINES: PLEASE CONTACT US IF:

- Construction work is being done in the vicinity of the artwork.
- You notice any scratches or marks on the surface of the painting or glass, or plexiglass covering the artwork.
- A piece of artwork does not seem secure on the wall.
- You notice any warping of the frame or canvas.
- You question the security of the location where a piece of art is hung, i.e., the area becomes unoccupied, or it is not locked at night.
- You notice direct sunlight on a piece of artwork; sunlight fades the pigments in many paints and must be avoided.
- There is any theft or vandalism of artwork. Theft and vandalism are not covered under the 1Percent Gallery insurance policy and are at the sole responsibility of the receiving Member.



INSURANCE

- The 1Percent Gallery carries insurance on Art Loans subject to \$1,000.00 deductible for accidental loss or damage, per item, as long as the attached Care & Handling Guidelines are observed during the course of the loan. By signature of an authorized staff member, the receiving company (via parent company, dba, corporate entity, LLC, or other agrees to reimburse the 1Percent Gallery for the deductible on any insured loss, up to \$1,000 per item. The receiver further acknowledges that in the event of damage or loss due to the failure by staff, agents, or contractors employed by the receiving company to observe the Care & Handling Guidelines, or if the work is de-installed or otherwise handled without the express written permission of the 1Percent Gallery the receiver will be liable for any damage or loss, up to the value listed above, without aggregate limit. The receiving company is responsible for ascertaining the limits of their own general liability insurance and obtaining any necessary underwritten or riders to cover the loaned works. A failure to do so will not abrogate the receiver of financial responsibility in the event of a non-insurable loss.
